Getting Started

Applying online for Criminal Defence Aid with the Public Defender's Office ("PDO")

Step 1:

You may access the online application form through the following means:

- a) <https://go.gov.sg/applypdo>;
- b) Scan the QR code below; or




- c) From the PDO's website (<https://pdo.mlaw.gov.sg>)



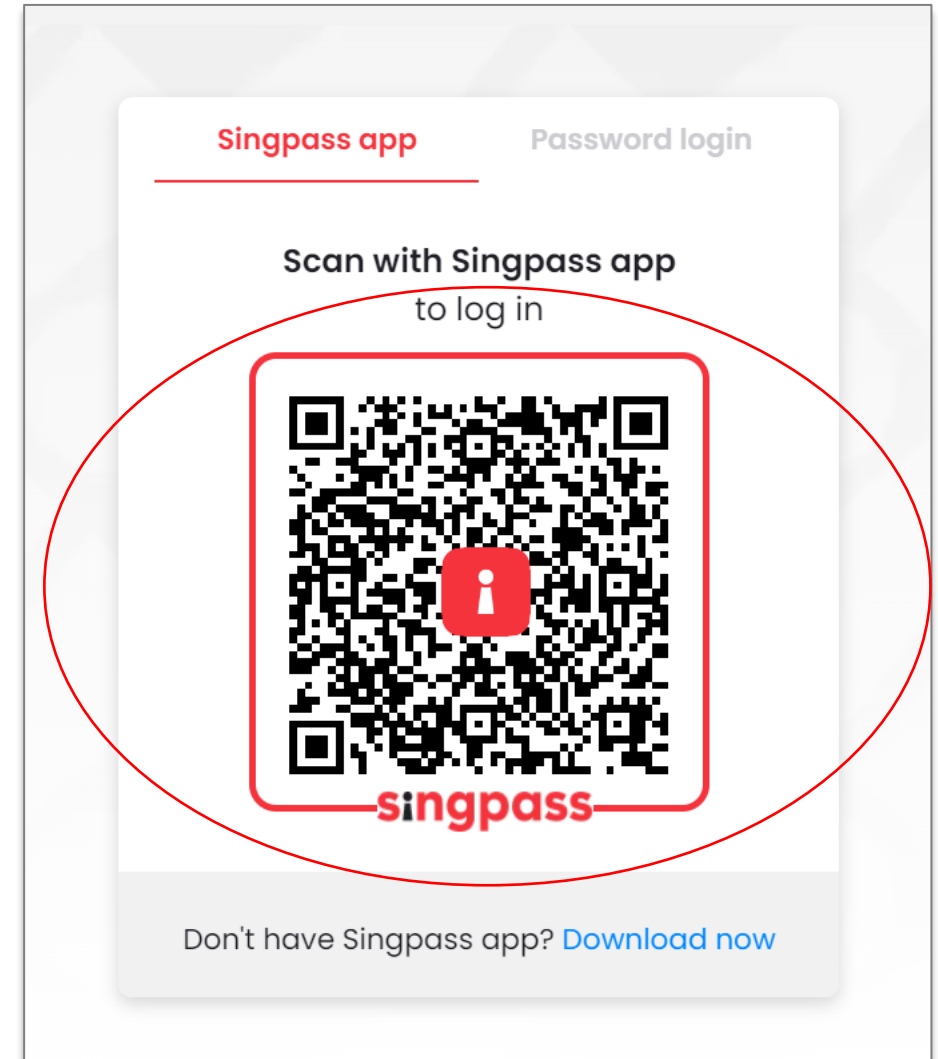
